Judge William A. Clark, retired, the Lincoln Society of Dayton.

- Native Daytonian, Fairview High School
- Attended the University of Michigan, undergraduate and law school
- Commissioned officer in the Air Force, served in the Judge Advocate General Corps on active duty
- Practiced law for 32 years in Dayton
- Served as a United States Bankruptcy Judge for 21 years
- Retired in 2006
- Enjoys tennis, traveling, and reading with an emphasis on Abraham Lincoln
- Speaker's Bureau Committee Chair and Board member of the Lincoln Society of Dayton

Lincoln Society of Dayton: The Lincoln Society of Dayton is an Ohio nonprofit 501(c)3 corporation founded in 2003 to perpetuate the memory of Abraham Lincoln for all he did for our country. The membership of nearly 150 meets monthly at Carillon Park for educational programs concerning Abraham Lincoln. To commemorate his 1859 speech in Dayton against the extension of slavery into the territories, the Society raised \$200,000 for the bronze statue of Lincoln now gracing the Old Courthouse Plaza in downtown Dayton. In furtherance of his legacy and Dayton connection the Society strives to remind us of Lincoln's compassion, commitment to equality and justice for all. #### Hope Taft, Little Miami Watershed Network.

Hope Taft, as First Lady of Ohio, 1999-2007, transformed the Governor's Residence into a Living Museum to preserve the property's rich heritage and created a showcase of artistic, industrial, political, geological and horticultural histories of Ohio for educational purposes. This project included the Ohio Heritage Garden, Ohio's botanical garden of native plants, designed to replicate the major ecosystems of the state. She still oversees the garden's development and maintenance as chair of the Heritage Garden Committee of the Friends of the Ohio Governor's Residence and Heritage Garden, a non-partisan, non-profit organization and organizes over 100 volunteers to help maintain it on a yearly basis.

She is an honorary Master Gardener and an Ohio Certified Volunteer Naturalist. She is a trained instructor for the Landscape for Life program developed by the Lady Bird Johnson Wildlife Center, the US Botanical Garden, and the American Society of Landscape Architects.

She joined neighbors to form Little Miami River Kleeners and the Little Miami Watershed Network to help preserve and protect the Little Miami River. A former board member of the Aullwood Audubon Center and Farm, she is a member of the Garden Club of Dayton.



Hope married Bob Taft in 1967. They live in the Dayton Ohio area. The Taft's have one daughter, Anna, who started the Tandana Foundation in 2006 and recruited her mother to be president of the board. The Tandana Foundation weaves friendships and empowers communities in Ecuador and Mali, West Africa, through scholarships and volunteer vacations focused on health care, gardening and community infrastructure.

2018 is the 50th anniversary of the state and national scenic river acts. The Little Miami River was the first river in Ohio to get both designations. Glenn Thompson, Dayton journal herald in the 1060s was instrumental in this effort. The Little Miami River is the longest scenic river in Ohio. This presentation talks about the importance of this river and clean water to the region and to animal habitat and people's health, safety and well-being. It will tell the story of its first 50 years and dream of what is possible in the next 50.

#### Juli Burnell, Founder & Director, Ellie's Rainy Day Fund

Dr. Juli Burnell is a 1989 graduate of the School of Professional Psychology at Wright State University. After working for several years in private practice, she spent 17 years on the staff of the Counseling Center at the University of Dayton. At UD she worked as the Coordinator of Group Therapy and the Coordinator of Clinical Training, in addition to seeing her caseload and teaching undergraduate and graduate courses. She also served as a Diversity Fellow on the team charged with conducting diversity training and community building in all departments across campus. She currently serves as Clinical Faculty with the School of Professional Psychology.

Dr. Burnell has always been interested in supporting the important roles humans and animals play in each other's lives. Since retiring from clinical practice, she has focused her energies on fostering those bonds. She started one of the first pet food pantries in the area, and was a part of the committee that created the Scout Dog Park, Greene County's first public dog park. She recently founded Ellie's Rainy Day Fund, a not for profit organization whose mission is to support and preserve the human-companion animal bond in Ohio's Miami Valley area through funding of veterinary services, education and advocacy. ERDF partners with veterinarians to assist families to be able to keep their medically challenged pets in the face of financial hardship. The overarching goal of Ellie's Rainy Day Fund is to keep families together by saving their pets' lives.

#### Megan Butcher, Business Development Specialist, Heartland, Dayton Region.

Megan Butcher is the Business Development Specialist from Heartland – Dayton Region. She started her Heartland career in May 2016 as the Admissions Director for Heartland of Miamisburg, then transitioned into her new role overseeing the community event planning for Heartland of Miamisburg, Kettering, Centerville, and Beavercreek. She earned her BS from Ohio University, and has her MBA and MBA from the Keller Graduate School of Management. Before entering the Healthcare world, she spent 11 years in higher education and 8 years in non-profit management with a local animal shelter.

They are a BBB accredited charity, a United Way Partner Agency and winner of the Eclipse Integrity Award for non-profit organizations. Diabetes Dayton offers help to anyone affected by diabetes, pre-diabetes, Insulin Resistance, or metabolic disorders. Every person or family affected by diabetes is welcome to utilize their assistance.



Diabetes Dayton does not receive funds from any national agencies, such as the American Diabetes Association (ADA) or the Juvenile Diabetes Research Foundation (JDRF). They are a local, independent agency that operates a small office in the Dayton area. Their funding comes from individual donations, memorials honoring loved ones, grants, corporations, foundations and their annual fundraiser. Since they are a local, independent agency all of the funds raised stay in the Dayton area to help local residents and their families. Mike is also in his 3rd term as an Oakwood City Board of Education member. Mike's business background is rooted in the motivation industry helping for 18 years to lead a small company's growth to almost 20 employees with annual revenues exceeding 16 million when the company closed in 2011. Mike decided to leave the for profit world for the for purpose world when he enrolled at the seminary. He is currently employed as the Executive Director of the Dakota Center.

The Dakota Center's mission is to provide a safe community atmosphere engaging Dayton neighborhoods and people of all ages in programs that educate the whole person.

The center is currently in its sixth decade of service tracing back to the vision that the Center's founders, Philip C. Hoelle, S.M., and William Hoben, had of building a community where there is education for the whole personmind, body, and spirit.

The center's original location was the old St. Emerick Social Hall on Dakota Street. A fire destroyed this facility in June 1974. The Dakota Center continued its programs at 408 N. Conover Street, using the Holy Name Church facilities. In 1976 Dakota Center moved to the MacFarlane neighborhood and operated out of a converted carriage house for nearly 25 years. Money set aside by the Society of Mary and funds raised from local individuals and foundations allowed for the construction of a new facility at Barnett and West 5th Streets. Staff moved their offices in October, 2000, and the new Dakota Center was dedicated in May, 2001.

Since that time, the Dakota Center has become a landmark in the MacFarlane neighborhood and offers a full calendar of activities. Clients number more than 1,350 who are involved in two or more programs per year. Accomplishments include students kept in school and alumni who contribute to society.

Carrie Scarff, Chief of Planning and Projects, Five River MetroParks.

Carrie Scarff is Chief of Planning and Projects at Five Rivers MetroParks, overseeing all planning, capital development, and special projects for the agency. After receiving her degree in landscape architecture from Ohio State, she practiced privately in Columbus and San Diego for ten years. She started with MetroParks in 1997, managing the development of RiverScape MetroPark in downtown Dayton. Carrie led the effort to complete key components of the regional bikeway system and developed MetroParks' outdoor recreation initiative. In 2008, she has chaired the Active Lifestyles Committee of the Greater Downtown Dayton Plan which spearheaded the RiverScape River Run and certification of Dayton as a Bike Friendly City. She's currently serving as co-project manager for the Dayton Riverfront Master Plan.

UD Graduate Joyce Reid Kasprzak's affiliation with education began as a reading and language arts specialist in Dayton Parochial Schools from 1969 to 1973. She began working with HBA as a volunteer in 2000 before becoming the Executive Director in 2006, after the passing of Founder William Bell. Before joining the organization, Joyce was Founder and CEO of the Dayton/Toledo/Columbus region of The Diet Workshop for more than 25 years. The national headquarters in Boston commended her franchise as the largest and most successful in the company's history. Honored by the New York Times for outstanding work in corporate weight loss programs, her innovation and vision won her Dayton's Female Entrepreneur Award. In 2010, she was recognized by the Dayton Daily News as one of the Top Ten Women for community contribution. She is married to Alan Kasprzak for 40 years and they have one son, Brian.

Children's Historical Publishing has developed a strong foothold in Miami Valley's education community and has created 30 titles and delivered over 560,000 Learning Activity Books with Teacher Curriculum Guides to local schools.

#### Bonnie Beaman Rice, Director, Leadership Honors Program, University of Dayton School of Law

In 2018, Bonnie Beaman Rice joined the University of Dayton School of Law as the Director for its Leadership Honors Program. Born and raised in Dayton, Ohio, she graduated, with Honors, from Indiana University and received her Juris Doctorate from the University of Dayton School of Law. For 11 years she worked as a trial attorney with the firm of Dodge, Parks, Little and Beaman (and its predecessors), with special emphasis in the areas of employment discrimination law and criminal defense.

Following her retirement from the Vandalia Court, Bonnie immersed herself in the world of volunteerism and non-profits. One of her activities included coordinating the Dayton Bar Association's Peanut Butter and Justice Drive. With the support of community partners and local bar membership, over 6,685 pounds of peanut butter, the equivalent of 3 1/3 tons, were collected for the Foodbank. Additionally, she has helped raise funds and public awareness for the American Veterans Heritage Center, volunteered at the Vandalia Police Department and served on the board of Advocates for Basic Legal Equality/ Legal Aid of Western Ohio (ABLE/LAWO).

Currently, Bonnie serves on the boards of Children's Historical Publishing, the Jewish Community Relations Council, The Lawyers Club and the Montgomery County Reentry Executive Committee where she co-chairs the Public Education and Advocacy subcommittee. She is also a member of the Montgomery County Public Defender Commission and is the Chair of Family Service Association.

Bonnie recently celebrated her 35<sup>th</sup> year of marriage to U.S. District Court Judge Walter H. Rice. They are the proud parents of four children and six grandchildren.

#### Nov. 20 to Nov. 21: Mawlid el-Nabi — Islam

This is an Islamic holiday that honors the birth of the Prophet Muhammad, who founded Islam. Shia and Sunni believers will celebrate on separate days by reading the prophet's teachings, according to Interfaith Calendar.

#### Nov. 28: Advent Fast begins — Orthodox Christian

Though Advent began this last weekend, the <u>fasting</u> starts midway through the month with only two weeks until Christmas. The holiday is celebrated by believers lighting Advent <u>candles</u>, hanging wreaths and attending church <u>ceremonies</u>, according to Interfaith Calendar.

#### Dec. 6: Saint Nicholas Day — Christian

This holiday honors the birth of Saint Nicholas, the saint who serves as a role model for gift-giving and is <u>commonly</u> <u>known as Santa Claus</u>, according to Interfaith Calendar.

#### Dec. 2 to 10: Hanukkah — Judaism

This is the <u>eight-day Jewish festival of lights</u>, which celebrates the Maccabean revolt in Egypt. Eight candles are lit with a menorah to honor the holiday.

#### Dec. 8: Immaculate Conception — Catholic

In the lead-up to Jesus' birthday celebration on Christmas, Catholics celebrate the day of Immaculate Conception to honor his mother Mary, who they say was preserved from original sin <u>for her entire life</u>.

#### Dec. 12: Feast Day of Our Lady of Guadalupe — Catholic

This is a primarily Catholic holiday celebrated by Mexicans and Americans of Mexican descent that honors the reported appearance of the <u>Virgin Mary in Mexico City</u>, according to Interfaith Calendar.

#### Dec. 17: Posadas Navidenas — Christian

This is a primarily Hispanic Christian holiday that commends Mary and Joseph's journey to Bethlehem to give birth to Jesus, according to Interfaith Calendar.

#### Dec. 21: Solstice — Wicca/Pagan



Solstice is the point in the year "when the earth is most inclined away from the sun. It is the most southern or northern point depending on the hemisphere," according to Interfaith Calendar. Pagans and Wicca believers will celebrate that event through Yule, in which believers also honor "the winter-born king, symbolized by the rebirth of the sun," Interfaith Calendar explained.

#### Dec. 25: Christmas — Christian

Christmas is a primarily Christian holiday that celebrates the birth of Jesus Christ. Many will attend <u>church</u>, <u>have family</u> parties and exchange gifts, according to Interfaith Calendar.

#### Dec. 26: Zarathosht Diso (Death of Prophet Zarathustra) — Zoroastrian

Unlike many of the other holidays in the month, Zoroastrians honor the death of their prophet, Zarathustra, who founded Zoroastrianism, one of the world's oldest monotheistic religions.

#### Dec. 30: Feast of the Holy Family — Catholic

Catholics use this day to honor Jesus, Mary and Joseph, according to Interfaith Calendar.

#### Dec. 28: Holy Innocents Day — Christian

Christians solemnly honor the <u>deaths of children killed by King Herod</u>, who was attempting to kill Jesus, according to Interfaith Calendar.

#### Dec. 31: Watch Night — Christian

For Watch Night, Christians will thank God for the safety they received during the year, according to Interfaith Calendar.

#### Jan. 24: Rohatsu (Bodhi Day) — Buddhist

This holiday celebrates the historical Buddha's decision and vow to sit under the Bodhi tree until he reached spiritual enlightenment. It's celebrated through meditation and is embraced similar to how Christians celebrate Christmas to honor Jesus Christ.

## **Holt Street Miracle Center Gilbert and Founder Mrs. Fletcher**

Motivated by her own humble beginnings, Mrs. Willa "Mother" Fletcher used her retirement savings to invest in the creation of the Holt Street Project. In 1991 The Holt Street Project was created out of Mother Fletcher's passion to relieve the suffering of the poor and less fortunate. Mother Fletcher and her loving son, Walter Gilbert, teamed up to buy and restore the old building that is currently known as Holt Street Miracle Center

Their mission is to provide transitional and long-term housing to our homeless veterans and their families and to work with various agencies that will <u>provide</u> social services, childcare, legal, medical, and <u>mental health</u> services to homeless veterans. HSMC mission is to develop an integrated system for long-term client <u>tracking</u> and coordinate our outreach efforts with other agencies.

#### Fatherhood Coordinator - Montgomery County Dept. of Job & Family Services

Michael Newsom, MPA, is the Fatherhood Coordinator for Montgomery County Department of Job & Family Services and leader of the Montgomery Fatherhood Initiative (MCFI) in Dayton, OH.
