### **Bruce A. Langos, Executive Director, Criminal Intelligence Center**

Bruce Langos is the Executive Director of the Criminal Intelligence Center for the Montgomery County Sheriff’s Office. Langos is accountable for a centrally located unit responsible for conducting in-depth regional analysis of crime and to share that analysis with the law enforcement agencies. This analysis provides a comprehensive view of the criminal environment within Montgomery County, allowing law enforcement personnel to make more informed decisions in the areas of strategic planning, tactical deployment, and aids investigators in solving crimes. Langos establishes partnerships with local, state and federal law enforcement agencies and expands the key philosophy of initiative – accurate use of timely crime data, use of “big data” technology to complement and enhance traditional crime-fighting strategies – to all law enforcement agencies.

Bruce Langos previously served as Chief Operations Officer for Teradata Corporation. He was accountable for all operational functions across the company worldwide including supply line management, global procurement, advanced manufacturing, logistics including service parts logistics, real estate, aviation, corporate security, intellectual property licensing, and designs and implements programs that strengthen the company’s processes and increase operating efficiency. He also led the company’s sales support and order management functions.

Langos started his career at NCR Corporation and held positions of increasing responsibility including OEM product sales, product marketing, product line management, strategic planning, and intellectual property licensing.

Langos was Senior Vice President of Global Operations for NCR Corporation responsible for improving operational efficiencies company wide. He was also vice president of corporate real estate and oversaw a major initiative to ensure that NCR's global real estate holdings were appropriately aligned with the company's business needs.

Langos serves on the Business Advisory Board for the Sooin College of Business for Wright State University. He is also a Governor appointed Commissioner for the Third Frontier Commission in Ohio and Trustee on the Wright State University Board of Trustees.

Langos is a State of Ohio Certified Humane Agent and is Chair of the Montgomery County Drug Free Coalition.

Gary J. Weston has over 40 years of experience leading, managing, supporting, and providing legal services for low-income persons, persons with disabilities, and seniors.

He has served as Executive Director of the Legal Aid Society of Dayton, Maryland Disability Law Center, and Florida's Advocacy Center for Persons with Disabilities.

He is currently a senior attorney with Legal Aid of Western Ohio, where he specializes in providing legal services to older persons. He leads the Plan Ahead & Protect Yourself Series for Seniors, which is designed to engage, educate, and empower elders to understand their legal rights, protect themselves from abuse and victimization, and preserve their safety, income, assets, and independence.

He is an active member of Montgomery County's Collaboration Against Abuse, Neglect & Exploitation (CAANE), Montgomery County's interdisciplinary team. He recently served as chair of the Steering Committee for a 6-month stakeholder series, "Combatting Elder Abuse, Neglect and Exploitation: A Community Discussion."

At the January Presidents Club meeting, he will discuss both the "Plan Ahead & Protect Yourself" project and CAANE's work to combat elder abuse, neglect and exploitation.

### **Please Note: Board of Directors meeting at 1:00 pm after our meeting**

As a service club member, I ask myself what more can I do to serve my community? What more can we do to help ourselves and others to not feel lonely or separated during the Winter months? We are vulnerable and can suffer from Emotional, Behavioral, Psychological from the lack of Physical Human connections during the Winter months;

Here are some information and tips.

- 1. Senior isolation increases the risk of mortality.** According to a study in the Proceedings of the National Academy of Sciences, both social isolation and loneliness are associated with a [higher risk of mortality](#) in adults aged 52 and older.
- 2. Feelings of loneliness can negatively affect both physical and mental health.** Regardless of the facts of a person's isolation, seniors who feel lonely and isolated are more likely to report also having [poor physical and/or mental health](#), as reported in a study using data from the National Social Life, Health, and Aging Project.
- 3. Social isolation makes seniors more vulnerable to elder abuse.** Many studies show a connection between [social isolation and higher rates of elder abuse](#), reports the National Center on Elder Abuse. Whether this is because isolated adults are more likely to fall victim to abuse, or a result of abusers attempting to isolate the elders from others to minimize risk of discovery, researchers aren't certain. A critical strategy for reducing elder abuse is speaking up: abuse, neglect and exploitation often go unreported. As for prevention, maintaining connections with senior loved ones helps us ensure their safety. We have had some excellent speakers on this subject; Invite your senior citizen/neighbor to a Club meeting, help them and ourselves to stay connected.

### **Breaking Bread is a good way to connect with others!**

#### **What can we do as Service Work or being a Good Neighbor?**

Check on the elderly in your community/neighborhood, a phone call is always nice, shovel their snow for them, invite them over or fix them meals they can just heat up. How about a family movie night bring your families to them in case they do not have family or if their family lives out of town? The elderly has made some remarkable contributions in life and have some of the most interesting stories to tell. Being a good listener always helps. Ask them if they want to journal their life history. Make some memories take pictures if appropriate. Go to the grocery store for them. Help them to understand they are cared for and have value!

I am reminded of this powerful quote by Erma Bombeck: *'When I stand before "God at the end of my life, I would hope that I would not have a single bit of talent left and could say, I used everything you gave me'.*

### We have three excellent speakers this month

#### **Andrew Sawyer is the Site Manager/Site Anthropologist at SunWatch Indian Village/Archaeological Park,**

SunWatch is a partially reconstructed 600-800-year-old Fort Ancient period American Indian village on the south side of Dayton. Andrew holds a BA in Anthropology from Miami University and an MA in Anthropology with a specialization in Archaeology from the University of Denver.

Andrew's thesis research was carried out on an early 13<sup>th</sup> century pueblo site near Zuni, NM, a site contemporaneous with the 13<sup>th</sup>-14<sup>th</sup> century occupation at Sun Watch. Andrew has been at Sun Watch since September of 2002 and along with his duties at SunWatch he is also an Adjunct Instructor in the Department of Sociology, Anthropology, and Social Work at the University of Dayton where he teaches Anthropology courses

#### **Varun Mahajan, M.D. DABR, Chief Executive officer for Mahajan Therapeutics, a Mental Health and Drug Addiction Agency**

Dr. Mahajan was raised in Dayton Ohio and graduated from the Miami Valley school. He was accepted into an eight-year medical program at Case Western Reserve University, in Cleveland Ohio, where he completed his undergraduate degree in management, and stayed for medical school. He completed a five-year residency in radiology in Brooklyn New York, and then matriculated as a fellow in breast cancer radiology at the University of North Carolina, Chapel Hill. He has been a past attending at the Susan Komen Center and quantum radiology in Atlanta, prior to moving back to Ohio.

His passion for serving the community, love of mental health and drug addiction treatment, and close hometown roots, were all reasons for his return to Ohio. Dr. Mahajan currently serves as chief executive officer for Mahajan Therapeutics, a mental health and drug addiction agency with presence in Dayton and southern Ohio.

The Executive Director at Friends of The Castle, Inc. is Lisa Hansford. Ms. Hansford's undergraduate degree is in Social Work (BSW) from Capital University. She also was awarded a Master (MA) in Conflict Analysis and Engagement from Antioch University Midwest. She has been a Licensed Social Worker (LSW) in good standing since 2006. She began her career at The Castle on Monday, October 31st, 2016.

Ms. Hansford brings a unique and varied blend of education, knowledge, and skills to her new position including experience in administrative and clinical oversight of mental health and chemical dependency organizations. She was most recently employed as a School Based Therapist for South Community, Inc. Prior to that, she was

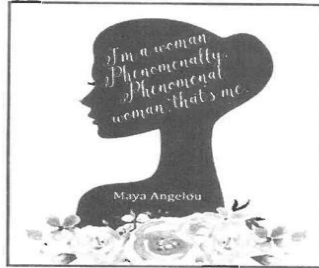

The Presidents Club of Dayton has announced that Dr. Roy G. Chew is the 69th recipient of the region's 2019 Citizen Legion of Honor award. The award, given every year since 1951, is the oldest, most continuous and prestigious recognition of volunteer servant leadership in the Dayton region.

Roy Chew is the now retired president of Kettering Health Network and is a well-respected leader in the Dayton region. Dr. Chew began his career at Kettering Medical Center in 1976. He quickly rose through the ranks and took on the role of president of Grandview Medical Center, then later, Kettering Medical Center. During that time, Dr. Chew initiated the development of a Level II Trauma Center, a Level III Newborn Intensive Care Unit, a Neuro Rehabilitation and Balance Center, and a Service Line growth strategy. Dr. Chew also developed plans for a new Kettering Cancer Center across the street from Kettering Medical Center and helped to secure major gifts to support construction.

While Dr. Chew has left a lasting impression on Kettering Health Network, he has also given back to the Dayton community, never shying away from an opportunity to serve. He's held positions on the Workforce Policy Board for Montgomery County, the Oikos Community Development Corporation Board, the Grafton Hills Neighborhood Association and Dayton Art Institute Community Development Board, the Greater Dayton Area Hospital Association Board, the Dayton Area Chamber of Commerce Board, the Community Health Centers of Greater Dayton Board, the Miami Valley Council Boy Scouts of America Board, the Montgomery County Five-Year Financial Planning Committee and more. In 1916 a group of civic-minded women met to plan the establishment of an organization to provide women of the area with a center for social, civic and literary activities.

Good Shepherd provides transitional housing for young men in our Life Recovery Program and Aftercare Program. Services include drug and alcohol guidance coaching, men's issues, groups, AA meetings, crisis coaching, Adventures Thrift Store, life skills, work training, Bible Study, career coaching, Celebrate Recovery 12-steps, savings plan and hope for the future for a new life.

#### The Presidents Club of Dayton honors Roy Chew with top volunteer award

DAYTON, Ohio – The Presidents Club of Dayton has announced that Dr. Roy G. Chew is the 69<sup>th</sup> recipient of the region's 2019 Citizen Legion of Honor award. The award, given every year since 1951, is the oldest, most continuous and prestigious recognition of volunteer servant leadership in the Dayton region.

Roy Chew is the now retired president of Kettering Health Network and is a well-respected leader in the Dayton region. Dr. Chew began his career at Kettering Medical Center in 1976. He quickly rose through the ranks and took on the role of president of Grandview Medical Center, then later, Kettering Medical Center. During that time, Dr. Chew initiated the development of a Level II Trauma Center, a Level III Newborn Intensive Care Unit, a Neuro Rehabilitation and Balance Center, and a Service Line growth strategy. Dr. Chew also developed plans for a new Kettering Cancer Center across the street from Kettering Medical Center and helped to secure major gifts to support construction.

While Dr. Chew has left a lasting impression on Kettering Health Network, he has also given back to the Dayton community, never shying away from an opportunity to serve. He's held positions on the Workforce Policy Board for Montgomery County, the Oikos Community Development Corporation Board, the Grafton Hills Neighborhood Association and Dayton Art Institute Community Development Board, the Greater Dayton Area Hospital Association Board, the Dayton Area Chamber of Commerce Board, the Community Health Centers of Greater Dayton Board, the Miami Valley Council Boy Scouts of America Board, the Montgomery County Five-Year Financial Planning Committee and more. Dr. Chew has also been a long-time member of the Rotary Club of Dayton and Kettering Kiwanis, and is a Leadership Dayton alum.

Dr. Chew's passion is healthcare, and as such, he's devoted time and effort to non-profits working to raise awareness and research funds. Dr. Chew has held volunteer leadership positions for the American Heart Association's Heart Walk Campaign, the Walk to Cure Diabetes Campaign, and the Alzheimer's Walk Campaign.
